Planning News important to Berkhamsted

The Erostin proposals for 'The Bourne Centre' (the town centre redevelopment) have recently been, on display at the Civic Centre, Berkhamsted. There appears to have been a lot of positive thinking by those responsible for the scheme design although judgements are as always subjective when it comes to elevational proposals involving the new alongside old and familiar buildings. We should bear in mind that it has taken well over three years for a serious plan to be put forward in response to the Dacorum brief and if the centre of the town is not to be left to stagnate, we should try to be constructive.

Department of the Environment guidelines to planning authorities currently state that listed buildings should be kept in their original positions and only re-located as a last resort in preservation. Architects Lyons Sleeman and Hoare are to be commended for having conceived a scheme that features the Grade II listed barn (which is presently a part of Mcllroys premises) as an archway entrance to the proposed mall, which would give more members of the public a chance to appreciate its crafted construction.

As always, traffic and parking need special attention and we are asking Dacorum Borough Planners to give special attention not only to the longer term traffic needs of the town centre, but also in particular to the interim measures that will be necessary during construction if the development goes ahead. Perhaps phased construction or advance provision of parking spaces offer advantages, The period of construction, as with most projects, bypasses included, invariably means some inconvenience. We hope that townsfolk will take the trouble to find out the pros and cons of the proposals and make their considered views known to councillors and the Planning Authorities concerned. Dacorum Borough Council's Development Control Committee will consider the applications on 20th August.

The site adjacent to Hall Park Garage has been the subject of several planning applications recently and it does look as if dwellings will be erected on the site, which we think is a much better option than D.I.Y. retail premises.

The Bypass

At last the Department of Transports side roads order for the town's bypass has been published, and the BCA officers have had so much contact with the design engineers at the Eastern Regional Office at Bedford that they were kind enough to send us a set of the documents including the drawings.

One could perhaps argue that the passing of much time has led to some improvements in the scheme. The dual carriageway bypass no longer includes a roundabout at the Chesham Road junction with four new slip roads. Let us hope that a further public enquiry, that looks likely, can be carried out without too much delay.

Litter

Here is a matter close to the hearts of many members and also of town councillors. We have carried out several litter sweeps along by the canal, and have been in touch with Dacorum Borough Council Works Department not only to gain an understanding of current litter clearance measures that they carry out but also to see how the Association can co-ordinate its activities on litter clearance.

Berkhamsted Youth Club

Following the offer from Dacorum Borough Council of a parcel of land at Lagley Meadow for the citing of a Youth Club, the Management Committee is to engage a firm of architects to draw up plans to the outline planning stage. Fund raising is, as always, of the utmost importance and, in addition to local people, Trusts and companies who support charity youth projects are to be approached. Let's hope that this really is the beginning for the achievement of a much needed basic local facility.

Community Adviser Scheme

The Hertfordshire County Emergency Plans Officer, Mr.D.Moses, wants to recruit more volunteers in Berkhamsted for the Community Adviser Scheme in connection with Civil Protection. An introductory meeting on 13th May at Berkhamsted Civic Centre was very poorly attended, though our representative was there amongst the few.
